

## 100% DEPOSIT BONUS

### A. Introduction

1. **Traders Capital Limited (herein "Company") operating under trading name TTCM** is a limited liability Company, incorporated in Bermuda under section 14 and 6/132C(1) of the Companies Act 1981 and registered with the Registrar of Companies under Company number 54135, with registered address 5th Floor, Andrew's Place, 51 Church Street, Hamilton HM 12, Bermuda (hereinafter called the "Company").
2. The "100% Deposit Bonus" Terms and Conditions is an integral part of the "*TTCM Business Terms and Policies*" and provisions set herein are considered as an annex of all "*TTCM Business Terms and Policies*".

### B. Specific "100% Deposit Bonus" Terms

1. TTCM 100% Deposit Bonus credits (hereinafter, "Promotion") begins on June 15th, 2020 and will run indefinitely, until TTCM (hereinafter, "Company") determines otherwise.
2. The Promotion is available to all new and existing live account holders who deposit \$300 or more from June 15th, 2020, indefinitely (hereinafter, "Participants").
3. The 100% Deposit Bonus will be credited (as credit) to the participant's live account for each deposit above \$300, up to a total amount of \$10,000 deposit.
4. The validity period for this offer is 90 days from the day the 100% Deposit Bonus was added to the account.
5. The conversion ratio is 1 closed lot round turn for 5\$ prize value, therefore if the 100% Deposit Bonus is USD1,000 the minimum of 200 closed lots will be required within 90 days.
6. If a participant has deposited several times (more than \$300), receiving multiple 100% Deposit Bonuses in the same account, then the lot requirements for all received bonuses must be covered.
7. The participant needs to trade the total volume required if he wants to transfer the 100% Deposit Bonus to his balance or withdraw it.
8. At the end of the 90 days period, if the participant has not reached the total volume required, the 100% Deposit Bonus will be withdrawn from the account.
9. Participants willing to transfer funds to their wallet without completing the required volume will have the 100% Deposit Bonus removed from their account.
10. At any time, if the participant wishes to transfer to his wallet or withdraw any amount from his account, the 100% Deposit Bonus will be removed.
11. At any time if the equity (balance + floating profit or loss) is equal or below the credit amount, all open positions will be closed automatically and the 100% Deposit Bonus removed.
12. The 100% Deposit Bonus is available for the following account types only: Classic, Pro.

14. If there is any conflict or inconsistency between the English version and the translated version of the Terms and Conditions, English will be the prevailing and predominant version.
